

# WB RSA CLUB Rules

#### **Everyone is welcome**

to dine in Gunners View Restaurant and Bar area.

### If you wish to buy alcohol you MUST be:

• A Waihi Beach RSA Club Member Please show current financial membership card to door/bar staff

• Guest of a Waihi Beach RSA Club Member or an Affiliated Club Member must show current financial card, guests will be issued with a Visitor Pass signed by door/bar staff. When the Member leaves, the Guest must leave also

### A reasonable standard of dress is required at ALL times.

- No singlets, hats or clothing with political or offensive insignia.
  The bar staff may provide you with a suitable shirt should your attire not comply.
  No dirty work boots or clothing
- For safety reasons, Footwear MUST be worn at ALL times, this includes children.

### Children must be always supervised.

No under-18's in the gaming machine area.

There are Smarty Bags available at the Restaurant, as well as toy boxes to help keep them amused.

**FAILURE TO COMPLY** with **Club Rules** and **Code of Conduct** may result in refusal of entry or removal from the premises.



## Code of Conduct

Access to and membership of the RSA is a privilege to be cherished and safeguarded. Accordingly, members, guests and visitors shall:

- Respect the rights of others to enjoy the activities, facilities and services provided by the RSA
- Interact with each other and with employees/staff in a courteous manner
- Refrain from behaviours that undermine the health and wellbeing of other patrons
- Bullying, Harassment, or Discrimination of another member, guest, visitor, or staff member, will not be tolerated
- Show due consideration to the needs of others, including their right to privacy
- · Comply with RSA policies, signage, and lawful directions of staff
- Access the RSA with proper identification
- Ensure children are accompanied by a responsible adult whilst on RSA premises or activity sites.
- Abide by the dress code of the RSA
- Not use foul or abusive language
- Not overindulge in alcohol
- Not bring food or drinks onto the RSA premises for consumption on the premises
- Handle property belonging to the RSA with care and diligence
- Not bring or have in their possession illegal materials while on the premises
- Refrain from representing the RSA in any form, unless properly authorised to do so
- Not deliberately tarnish the reputation of the RSA or bring it into disrepute
- Leave the premises or activity when requested, or having done so will not re-enter
- Acknowledge they may be recorded on closed circuit television (CCTV) cameras located inside and outside any venues or activities.

If a member refuses or neglects to comply with any of the provisions of the Constitution of the RSA or the By-laws thereof or be in the opinion of the Committee or the Committee 's duly constituted disciplinary committee/tribunal, guilty of any conduct prejudicial to the interests of the RSA or conduct which is unbecoming of a member or which shall render the member unfit for membership, the Committee or the disciplinary committee shall have the power to reprimand, suspend from all privileges of membership for such period as it considers fit, expel or accept the resignation of such member and to remove the person's name from the Register of Members.

The Code will be actively monitored by the RSA and if a breach occurs and can be proven, the RSA may initiate disciplinary or legal action against the relevant, member(s), guest(s) and/or visitor(s).
